



Privacy Policy

This Statement of Privacy applies to software and websites owned by IVSoftware LLC. For the purposes of this Privacy Policy, unless otherwise noted, all references to IVSoftware LLC include the [SasQuatch Find Anything](https://www.ivsoftware.com) application running on any platform and the www.ivsoftware.com and www.sasquatchfindanything.com websites. It governs data collection and usage. By using these websites or this application, you consent to the data practices herein described.

Introduction

Having an AI assistant is nice! But knowing that it hears literally everything you say? That is (or should be) unsettling! Perhaps we're numb to granting permissions, got a little overzealous along the way? We clicked OK to apps knowing where we are, who we're with, what we say, what we buy and how much we earn and spend. We routinely accepted terms of use allowing connected apps to monitor our health, mood, sleep. If you take medicine (either because our doctor says to or maybe just for fun) or like to enhance your love life in some way, isn't that personal? There needs to be a different option than revealing everything all the time.

It's our Mission

Our company exists to provide an alternative:

- That lets you be in control of your own connections and minimize your inevitable exposure to the to the autonomous AI data-mining invasion.
- That empowers you to to gather information, belongings and ideas and be able to find, search and process them with nobody looking or pummeling you with ads in response.

Our Policy in a Nutshell

We want to know as little about you as possible. This isn't personal—that's the point!

- To manage your software license, we'll need your basic contact information.
- Your app data is never stored on our servers (the opposite of what most web apps do).
- We'll never see or store your payment information (any purchases you make will go through one of the Microsoft, Google or Apple stores).
- Your searches will be private. We'll never mine, spy on, collect or aggregate them.
- We'll never share or sell the little bit of information that we do have with anyone.

Access to Google User Data

When our user requests it, and subsequently accepts and allows access on the required Google consent screen, the website and application will access, use, store, or share data on the user's Google account. This section describes the way we do this. Access may be [revoked](#) any time.

Purpose

Customers are given the option to grant access to their **Google Drive** user data for the purpose of synchronizing their SasQuatch databases across their devices, and to their **OpenID** profile information for the purpose of sharing add-on license purchases across device platforms.

Scope

The **website** acts as an intermediary to obtain OAuth credentials for the application. User will be presented with a consent screen to authorizing SasQuatch and the requested scopes. Upon success, website returns tokens to the application allowing it to perform file operations directly.

The **application** will create a visible folder named SasQuatch Drive Service in the root directory of the user's Google Drive and only modify files and folders in or below it. The app operates only on files that the app itself creates, in the specific binary formats used by the app (this excludes most Google Docs). Operations include upload, update, download, trash and delete. The app will not make any attempt to empty the trash or permanently delete files out of band.

Shared With Me

SasQuatch databases can be shared and assigned Viewer or Editor permissions just like any other file in the Google Drive. Any files shared with authorized user, in or out of the SasQuatch Drive Service folder and including Google Docs, will be visible to the application in queries designed to discover SasQuatch shared files. The application immediately discards any unrelated metadata acquired in this manner.

SasQuatch Find Anything maintains strict privacy by storing its application data only on the device running it. But this can be too much of a good thing (even for us!) because it doesn't let you sync your data, even between different devices that you own.

The solution (for customers who opt in) is to subscribe to a proprietary Google Drive add on. Google's Terms of Use policy essentially states that [what's yours stays yours](#), making it a good choice from the privacy standpoint. The purpose of the add-on is to optimize the data usage. This isn't sales mumbo jumbo—there's not even an air of mystery about it! Just a simple explanation:

You might have multiple, large databases open simultaneously in SasQuatch, with possibly hundreds of Content documents in each. If the database were to be placed in a normal Google Drive folder, changing *one* letter in *one* of the documents would blast the *entire database* to all your devices. Potentially, this could even make a big dent in your data plan! Google Drive add-on for SasQuatch efficiently identifies and updates just the changes.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, IVSoftware may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Numeric code for SSO with Google or other Social Media provider

If you directly disclose personally identifiable information or personally sensitive data through IVSoftware's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) signing up for special offers from selected third parties; (c) sending us an email message. All such third parties are prohibited from using your personal information except to provide these services to IVSoftware, and they are required to maintain the confidentiality of your information.

IVSoftware may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on IVSoftware or the site; (b) protect and defend the rights or property of IVSoftware; and/or (c) act under exigent circumstances to protect the personal safety of users of IVSoftware, or the public.

Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations inherent to the Internet which are beyond our control; and (b) security, integrity, and privacy of any and all information and data exchanged between you and us through this Site cannot be guaranteed.

Right to Deletion
